Diligent Prequalification Platform

Increase efficiency, reduce risk, increase quality, and accelerate provider onboarding in the prequalification of Technical Service Providers

The Diligent Prequalification Platform is an innovative new model for Provider prequalification to improve upon the prevalent resource intensive model whereby Sponsor standards are not known by the Provider or the Sponsor staff may lack technical expertise.

Diligent Centralized RFIs Focus on 3 Core Attributes:

TRANSPARENCY

- Core and technical Avoca Quality Consortium (AQC) standards shared with participating Providers
- RFIs based on AQC standards that were developed with Provider review and input

CONSISTENCY

- A single Core RFI utilized for all Providers and peer-reviewed by Sponsors/CROs
- Fit-for-purpose Technical RFIs specific to the service area offered by the Provider

EFFICIENCY

- Reduced time spent preparing and requesting completion of RFIs
- Opportunity to share completed RFI(s) across multiple Sponsor and CRO clients
- Greater amount of time available to focus on core, value-add activities

Diligent Prequalification is comprised of two elements: Centralized Requests for Information (cRFI) and Centralized Prequalification Audits (cPQA).

CENTRALIZED RFIs

Avoca continues to build a robust repository of completed Technical RFIs across several clinical service areas. All Providers submit Core RFI and Technical RFIs based on the services they offer. Several companies have already submitted RFIs, and the following technical RFIs are available:

- Bioanalytical Labs

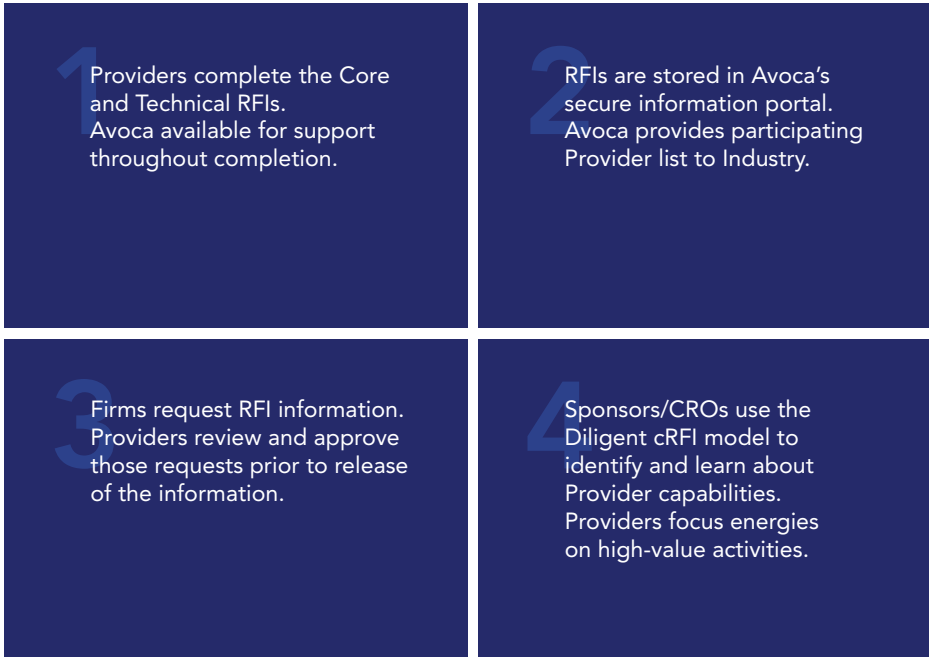
CENTRALIZED PREQUALIFICATION AUDITS (cPQA)

Diligent centralized audits are rigorous prequalification audits based upon the Avoca Quality Consortium peer-reviewed Core and Technical Standards, and performed by highly experienced, Diligent-trained auditors. Multiple Sponsors/CROs may share the costs of a Provider audit, and Avoca retains audit information for further sharing with Provider-approved firms after the audit is complete. These audits are not intended to replace the Sponsors' or CROs' due diligence and quality oversight of their Clinical Service Providers. The Diligent Centralized Prequalification Audits offer an opportunity to greatly reduce the audit burden in time, cost, and resources for both Sponsors/CROs and Providers alike.

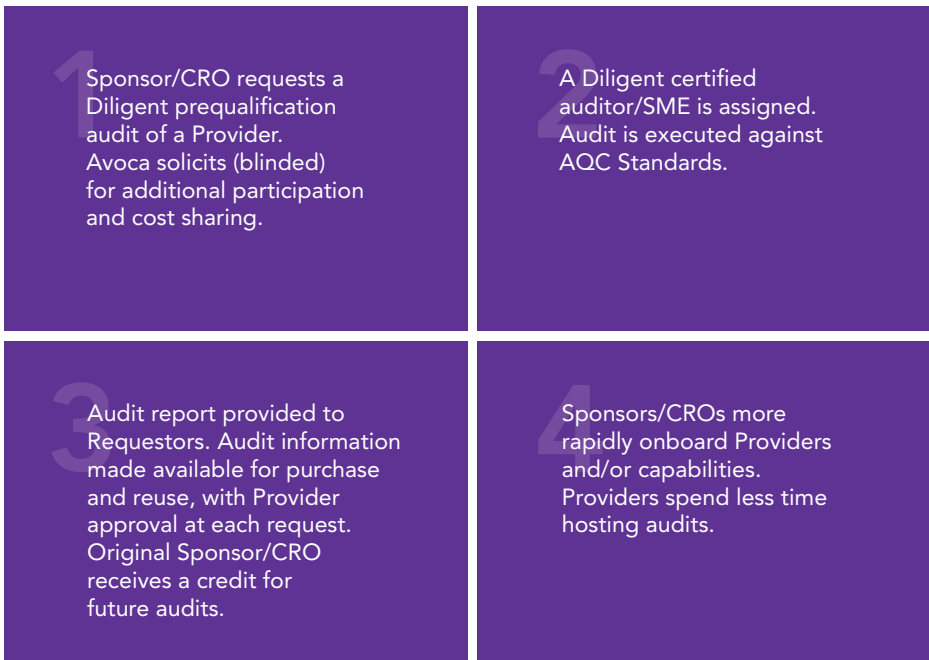
